COSMETOLOGY I	36 weeks	Course No. 8527
Elective		3 credits
Prerequisite: Recommendation of Counselor 3 periods		

Cosmetology I serves as a foundation for the entire cosmetology curriculum, familiarizing the student with basic procedures which will, with practice, lead to the skills of the occupation. Emphasis is placed on professional ethics, image development, and the skills required of a

COSMETOLOGY II	36 weeks	Course No. 8528
Elective		3 credits
Prerequisite: Cosmetology I 3 periods		

In this course, students expand on knowledge and skills which are required for licensure. Emphasis is placed on advanced technique, with increased speed and perfection. Lab work is performed on manikins, students, and patrons from the school and community in the school and in the salon. This allows students to gain the skills needed to ensure a smooth transition from school to employment in this industry. Students are encouraged to work in a salon as a stylist through the work experience program second semester.

Desirable Aptitudes

A student entering this field of study should have an interest in people and a pleasing personality. Good grooming, dexterity, coordination, a sense of form, good color concepts, and artistry are important traits to possess. Communication skills, knowledge of the basic art principles, and a basic understanding of chemistry and math is desirable.

Employment Outlook

Qualifying students (those who have maintained a C average with fewer than five absences for the year) will be eligible to participate in the work experience program during second semester. Students in this program work in the salon as beginning stylists. Students who have met all competency requirements will sit for their state board testing during the fourth nine weeks of school. Successful students will be licensed stylists upon graduation. After receiving this license, no additional training is required for entry-level positions in a salon environment. Salaries are determined only by the ability and ambition of the individual.
